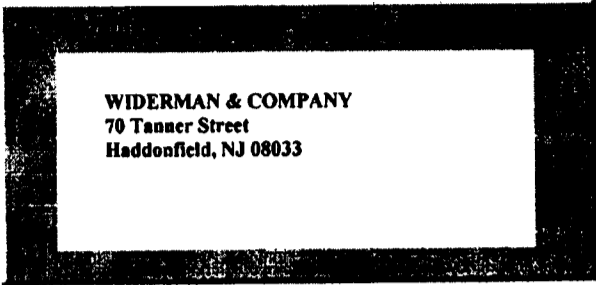

Whereas, the above bounden Principal desires to act within the Commonwealth of Pennsylvania as a Title Insurance
Agent and has applied to the Commonwealth for a license to act as such and is required pursuant to P.L.682, Act 79 of
1995, Section 726.1 to file this bond.

Now, Therefore, the condition of this obligation is such that if the above bounden principal shall fully and faithfully in
every respect observe and comply with the terms and provisions of the said P.L.682, Act 79 of 1995, Section 726.1 of the
Commonwealth of Pennsylvania, and shall satisfy any judgment rendered against them for violation of such statute, then
this obligation shall be void; otherwise to remain in full force and effect.
